Welcome, Rodeo Parents!

The Louisiana High School Rodeo Association truly welcomes your input and support during the 2011-12 Rodeo Season. The Adult Membership Program was organized to serve as a booster association and as an outlet through which you voice your opinion to the Board of Directors. As benefits of membership, you will be invited to attend the annual general adult membership Mid-Winter meeting that will be scheduled during the break and in conjunction with Rodeo Prom. Prior to and during the Finals, you will participate in the election of directors, which serve staggered terms. These directors, which are elected from all parts of the state, are the people you will contact throughout the year to offer opinions and voice concerns, if the need arises. It is mandatory that at least one parent of each contestant join.

Membership dues in the Adult Membership Program for 1 parent or guardian are included in your child's membership. A membership application form must be completed by that person and an additional form has been provided for your convenience. Dues are \$7.00 per person or \$12.00 per couple for parents of members residing at the same address. Adult members who are not parents of student members will pay \$25.00 per couple residing at the same address or \$15.00 per person. This will include a mandatory subscription to the *Rodeo News*, LHSRA's official publication, which keeps interested readers abreast of current LHSRA standings and activities. The *Rodeo News'* LHSRA pages serve as the official correspondence to adult members from LHSRA. Only election information is mailed during the year. Your child will receive the *Rodeo News* as a benefit of membership; thus, you pay the lower adult membership dues. Please enclose your membership form and dues with the membership material that your child is submitting at this time.

# LHSRA STUDENT MEMBERSHIP APPLICATION INSTRUCTIONS

All applicants must submit the following.

1. The NHSRA Membership Application and NHSRA Minor's Release must be completed in their entirety. Please TYPE or PRINT all information. The National High School Rodeo Association's Minor's Release, Assumption of Risk and Indemnity Agreement must be notarized. Signatures of the potential member, parents, or legal guardian, and the notary public all required. (The LHSRA entry blank will also require notarization)
2. **ALL** potential members regardless of new or renewing membership must submit a COPY of his/her birth certificate. THIS COPY WILL NOT BE RETURNED!
3. Any potential member must submit a copy of his/her final grades for the 2010-2011 school year. It should be an original copy of the transcript or grade report which must be obtained from the school counselor or principal. (If the member is entering after December 1, 2011, a copy of midterm grades for the 2011-2012 school year must be provided) **Even if you provided this information for state finals, you must resubmit at this time. Until grades are received, your application will not be processed.**
4. According to the NHSRA regulation, all homeschoolers must submit documentation of current Louisiana State Department of Education approval of your home school program. This must be submitted at the time of your new membership application, even if you competed at the State Finals.
5. Membership of at least one parent or guardian in the LHSRA Adult Membership is mandatory. Membership for 1 parent is \$7.00. Both parents may join for a total of \$12.00. Other interested adults may join at the rate of \$15.00 per person or \$25.00 per couple.
6. You will complete one entry form for the entire rodeo unless, with parental permission, you wish to add or delete events. Please note there are different entry forms for cowboys and cowgirls.

Complete your appropriate entry form in this manner:

- A. Select the events by having **BOTH** parents sign to the right of those particular events. (In certain special cases, in the second blank, the **ONLY** options are the words: "Death" or "Full Custody". Joint or domiciliary custodial parents must both sign.)
  - B. Bring your form to school and have the appropriate administrator sign it.
  - C. Bring your form to a notary and have the permission statement, with all necessary information and signatures notarized.
7. In addition to the proper paperwork, a money order or cashier's check in the amount of \$162.00 or \$167.00 (two adult memberships) made **payable to LHSRA**, must be included. This amount will cover the following MANDATORY expenses:

Any application received after Friday, September 16, 2011 may not be processed in time to enter the first rodeo. Those applications received after September 16<sup>th</sup> are also not guaranteed of being assigned their same back number as in 2010-2011.

**MINOR'S RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

We, the undersigned, hereby request that the below named minor (minor) be granted permission (1) to enter the restricted area, (2) to participate as a contestant, assistant, official or otherwise in rodeo events, (3) to compete for money, prizes, recognition or reward, (4) to be covered by participants' hospitalization insurance, if applicable, as limited by the master policy (all collectively hereinafter called "permissive entry").

In consideration of "permissive entry" to minor into the restricted area, which is the area from which admission to the general public is restricted, which includes, but is not limited to the rodeo arena, competition area, chutes, pens, adjacent walkways, concessions, and other appurtenances, we, the undersigned, on behalf of the minor and for ourselves, our personal representatives, heirs, next of kin, spouses and assigns, do hereby:

1. RELEASE, DISCHARGE AND COVENANT NOT TO SUE the rodeo committee, stock contractor, rodeo association, sponsors, arena operators or owners, and each of them, their officers, agents and employees (all hereinafter collectively referred to as "releasees") from any and all claims and liability arising out of strict liability or ordinary negligence of releasees or any other participant which causes the undersigned injury, death, damages or property damage. We, the undersigned, jointly, severally, and in common, covenant to hold releasees harmless and to indemnify releasees from any claim, judgement or expenses releasees may incur arising out of any of the minor's activities or presence in the restricted area.

2. UNDERSTAND that minor's entry into the restricted area and/or participation in rodeo events contains DANGER AND RISK OF INJURY OR DEATH TO MINOR, that conditions of the rodeo arena change from time to time and may become more hazardous, that rodeo animals are dangerous and unpredictable, and that there is INHERENT DANGER in rodeo which we each appreciate and voluntarily assume because the minor and we choose to do so. Each of the undersigned has observed events of the type that the minor seeks to participate in. We further understand that the arena surface, access ways or lack thereof, lighting or lack thereof, and weather conditions all change and pose a danger to the minor. We further understand that other contestants and participants pose a danger to the minor, but nevertheless, WE EACH VOLUNTARILY ELECT TO ACCEPT ALL RISKS connected with the minor's entry into the restricted area and/or participation in any rodeo events.

3. AGREE that this agreement shall apply to any incident, injury, accident or death occurring on the above date and FOR A PERIOD OF ONE (1) YEAR THERAFTER or until the minor's association membership expires, whichever shall last occur. All subsequent agreements and release documents signed by any of the undersigned shall amplify, but shall in no way limit the provisions of this document. The provisions of this document may be cancelled by any one of the undersigned by delivering to the above rodeo association written cancellation of this agreement which shall be effective 24 hours after the date said cancellation is actually received by the rodeo association.

4.
